***If you need help now:***

- ❖ If you or a loved one is experiencing thoughts of or has a plan of suicide or harm to self or others immediately call Psychiatric Emergency Screening Services at 856-845-9100. If you or your loved one is in imminent danger, call 9-1-1 immediately.
- ❖ If you are in need of direct access to mental health services, call Mental Health Urgent Care at 856-494-8160

***If you need someone to talk to:***

- ❖ If you are age 10-24, call 2<sup>nd</sup> Floor at 888-222-2228.

- ❖ New Jersey Vet2Vet is a 24 hour/7-day a week helpline coordinated by Rutgers University Behavioral Health Care. The helpline features peer counseling for veterans, members of the Air/Army National Guard, and family members. To access this service, call 1-866-838-7654


